

Legislative Report - July 2015

Thank you to the NHMS Legislative Committee and the physicians who testified and/or contacted legislators over the past six months. In New Hampshire, the efforts of individuals can and do make a difference in the legislative process!

HB 271 As of June 2, 2015, physicians are allowed to, "...prescribe, dispense, or distribute, directly or by standing order, an **opioid antagonist** to a person at risk of experiencing an opioid-related overdose or a family member, friend, or other person in a position to assist a person at risk of experiencing an opioid-related overdose." There is also immunity for those prescribing or providing the medication.

HB 136 On August 1, 2015, New Hampshire joins nearly a dozen other states when minors will no longer be allowed to go to **indoor tanning** salons.

HB 477, SB 3 and SB 133 For six months, NHMS staff worked with stakeholders to try to stop efforts by hundreds of New Hampshire businesses to enact a **workers' compensation** (WC) fee schedule for medical services. At the end of the day, a reasonable compromise was reached in SB 133. State law will no longer require a business or insurer to pay "the full amount" of a medical bill. The amended law requires payment of "reasonable" costs as justified by the medical provider, with the hope of encouraging more WC contracts for medical services and discouraging high-cost *outliers*. The bill also requires the collection of WC claims data to assist the Commissioner of Labor in defining "reasonable."

SB 84 NHMS spearheaded the effort to allow the prescribing of non-controlled drugs via **telemedicine** and helped achieve a compromise for certain controlled drugs to be prescribed via telemedicine at state certified community mental health or SAMHSA certified substance abuse clinics.

HB 508 This bill lays out the process by which the NH Medical Malpractice Joint Underwriters Association (**JUA**) will be **dissolved**. NHMS anticipates that once dissolved, there will be up to \$85 million in excess surplus premiums to be returned to JUA policyholders. Any unclaimed surplus will once again be earmarked for loan repayment for providers in underserved areas of the state. Also included in the bill is language from **SB 137**, a bill that proposed parity for **oral chemotherapy drugs**. The bill passed the Senate but was retained by the House Commerce Committee. A last minute amendment put the language in SB 137 on HB 508 and will limit out-of-pocket costs to consumers for oral chemotherapy drugs.

HB 383 This bill was a casualty of the 2015 legislative session. Notwithstanding lobbying efforts by DHHS, physicians and NHMS, New Hampshire will <u>not</u> have the necessary statutory authority for an operational **state vaccine registry**.
